All Reception pupils are involved and fire regulations limit the number of seats available. In an effort to offset costs there will be a nominal charge of £1.00 per ticket which will include refreshments. Initially tickets will be limited to **TWO TICKETS PER FAMILY** in total. It is school's expectation that 1 ticket is provided for each parent. All family units are different so you are expected to talk with the other adult who has parental responsibility about ticket organisation. Tickets will be on sale from **TUESDAY 14TH NOVEMBER 2017** and they will be issued on a first come, first served basis and sent home with your child. Monies will need to be sent with the reply slip. Should there be any tickets remaining following the two per family allocation then these will be available from **MONDAY 4TH DECEMBER 2017**. Please ring the school office and ask to be included on the reserve list if you would like to put your name down for any spare tickets.

PARENTS PLEASE NOTE THAT ONLY ADULTS ATTEND THESE PERFORMANCES. **YOUNGER CHILDREN / BABIES / PUPILS WILL NOT BE ADMITTED.** NO FACILITY OF SUPERVISION WILL BE AVAILABLE FOR YOUNGER PUPILS / CHILDREN ON SITE.

As ever, our school responds to the needs of the pupils here at Green Meadow so parents must make their own arrangements for the child care of babies and younger children. This policy has worked successfully now for several years so we would ask for your co-operation again this year.

Whilst we welcome the opportunity for parents to film/ photograph their own child(ren) for personal use. **We would remind you that you are responsible for posts on social media sites. We would discourage you from posting any photography on social media but if you do decide to do this please only post your own child(ren) for safeguarding reasons.**

We would also remind you that we cannot allow people to stand on chairs to seek a better vantage point. Health and Safety regulations clearly restrict the appropriacy of this practice.
